### Award Criteria

The Charity must:

- Complete a Bath Building Society Charity Awards application form.
- Have a turnover of less than £250,000 per year.
- Operate and benefit people in Bath Building Society's business areas of Bath and North East Somerset, Somerset, Wiltshire, Gloucestershire and Bristol.
- Agree to Bath Building Society using photos and text for marketing/media purposes.
- Take up the funding within six months of being notified.

Bath Building Society will not fund individuals or families. Bath Building Society staff and their suppliers and Marketing/PR associates may not apply.
